first part. and Alfred Cantrell of the second part. all of South Carolina Witnesseth that the said parties of the first part. for and in consideration of the sum of One hundred and fifty dollar the receipt of which is hereby acknowledged. has given granted bargained sold and conveyed and does hereby give grant bargain sell and convey to the said party of the second part his heirs and assigns all that tract or parcel of land lying in North and South Carolina known as the Panther Mountain Tract bounded as follows. Beginning on a chestnut being 122 W 26.50 chains to a stake on the state line thence S 80 W 14 chains with state line to a stake thence S 37 E 21 chains to a stake near a Rock Bluff thence N 65 E 69.50 to a stake on the state line thence with lines of John Hodges Grant 36 1/3 E 5.50 chains to Black Oak thence N 48 E 8 chains to a white oak thence N 5 E 7 chains to a stake thence S 75 W 44.50 chains to a stake thence N 10 W 15 chains to a white oak near the old Spring thence N 85 W 5.50 chains running near the old house to a Black Oak on the Branch thence S 40 W 10 chains to a Sourwood on the Branch thence N 46 W 8 chains to the beginning. To have and to hold the same with the appurtenances thereunto belonging. To Alfred Cantrell the said party of the second part. his heirs and assigns forever and the said party of the first part for the consideration aforesaid does hereby covenant and agree to warrant and defend the premises to the said party of the second part his executors administrators and assigns against the claim or claims of the heirs of the party of the first part as Executors and Executrix and no further and does further covenant that the said Davis W Hodges Sarah Hodges Executor and Executrix of John Hodges dec is seized of the premises in fee simple and has power as far as Executor and Executrix to convey such an estate by this indenture and has done the same by these presents. for and in consideration of the sum of Fourteen thousand and seventy six Dollars to us in hand paid by Samuel A Moon of the State and District aforesaid we have granted bargained sold and released and by these presents do grant bargain sell & release unto the said Samuel A Moon a part of the tract of land containing Two thousand & Twenty four and a half acres more or less surveyed to Jacob Davis and granted to him 30th Oct 1786 in the District and State aforesaid on both sides of Horsepen Creek and bounded by Sarah Baldwin John Higgins G B Thomason & others. Together with all and singular the rights members hereditaments and appertinances to the said Samuel A Moon his heirs and assigns forever and we John M Howard and P C A Howard Executors of Samuel Howard deced do hereby bind ourselves our heirs Executors Administrators and assigns to warrant and forever defend all and singular the above mentioned premises unto the said Samuel A Moon his heirs Executors administrators and assigns forever against ourselves our heirs Executors and administrators and against every other person or persons whomsoever lawfully claiming or to claim the same or any part thereof. In witness whereof we have hereunto set our hands and seals this ninth day of November One thousand eight hundred and fifty three and in the seventh year of the Independence of the United States of America (N B) Eleven Acres of the above described land excepted for Samuel Baldwin off of the lower end of the tract to include a part under fence.
