H J Gilbreath Esq	Deed of Land	The State of South Carolina Greenville District Know all men by these presents that I Hardy J Gilbreath Executor of the last will and testament of Lewis Land late of said District deceased and by the directions of said will for and in consideration of the sum of Five Hundred and fifteen Dollars to me in hand paid by Mrs Elender W Clark the wife of John H Clark the receipt whereof is hereby acknowledged have gra- nted bargained released sold and conveyed unto W A Clark Trustee of the said Mrs Elender W Clark in trust for the exclusive use benefit and advantage of the said Mrs Elender W Clark the following tract or parcel of land situate lying and being in the District and State aforesaid on the south bank of Enore River containing Two hundred nineteen and a fourth acres more or less bounded by lands of Joseph Cooper Mr Broadly America Fowler Joseph A Legon & John H Clark begining on a Stake on the McElhany Road thence N 18° 10' 3" E 65 to a Post oak at the head of Coopers Spring branch thence down said branch to a Poplar & thence N 28° 10' 22" E 65 to the mouth of Ditch then a branch line to head thence N 15° W 7' 62 to a Stake in a Black Jack Stump by a pine & thence N 77° 6' 24" E 17 to a Red oak & thence South 29° 13' 6' 53.50 to Post oak & thence S 20° 12' 6' 20.80 to Post oak & thence S 76° 12' W 27.03 to the begining Together with all and singular the rights members hereditaments and appurtenances to the same belonging or in anywise incident or appertaining to have and to hold all and singular the premises above mentioned unto the said W A Clark interest for the exclusive benefit and advantage of the said Mrs Elender W Clark who is to have use occupy and enjoy the said premises free from hinderance by the said W A Clark Trustee as aforesaid or any other person for and during her natural life and at her death the said premises to belong of right in fee simple to lineal heirs of the said Elender W Clark forever and I hereby bind my self as Executor of the last will and testament of Lewis Land <sup>deceased</sup> to warrant and defend the said premises against me and my heirs and against every person lawfully claiming or to claim the same or any part hereof Witness my hand and Seal this 25 <sup>th</sup> day of September in the year of our Lord one thousand eight hundred and fifty seven and in the Seventy and Independence of the United States of America the Eighty first. This indenture made the sixth day of  
February in the year of our Lord one thousand  
and eight hundred and fifty seven between  
James H Randolph of the one part and  
G F Towns of the other part witnesseth Whereas the said James  
H Randolph has given his obligation for Five hundred Dollars to the  
said G F Towns trustee of the said Randolph to be paid to the said  
G F Towns trustee of aforesaid as by reference to the said obliga-  
tion will more fully appear which bears date Oct 7 1857 Now  
this indenture witnesseth That the said James H Randolph for  
and in consideration of the premises aforesaid and also in considera-  
tion of the sum of Five dollars to the said James H Randolph by the  
said G F Towns in hand paid at and before the sealing and  
delivery of these presents have granted bargained sold and released and  
by these presents do grant bargain sell and release unto the said G F  
Towns trustee as aforesaid all that lot or parcel of land in the town  
of Greenville wherein I now reside conveyed to me by C Gower cont-  
aining

more or less and situated on the street known  
as

Street in the plan of the Village. Together with all and  
singular the rights members hereditaments and appurtenances to the said  
premises belonging or in any wise incident or appertaining. To have and  
to hold all and singular the premises before mentioned unto the said G F  
Towns trustee and his heirs and assigns forever and I do hereby bind my  
self & my heirs Executors and administrators to warrant and forever defend  
all and singular the said premises unto the said G F Towns his heirs  
and assigns against me and my heirs and against every person whom  
soever lawfully claiming or to claim the same or any part thereof

Provided always nevertheless and it is the true intent and meaning  
of the parties to these presents that if the said James H Randolph his  
heirs Executors or administrators shall well and truly pay or cause to  
be paid unto the said G F Towns the sum of Five hundred Dollars  
according to the obligation above mentioned then and from thenceforth  
these presents shall be utterly null and void anything herein contained  
to the contrary thereof in any wise notwithstanding and it is covenan-  
ted and agreed upon by <sup>1</sup> and between the parties to these presents that  
until default shall be made in payment of the aforesaid sum as before  
set forth and the interest for the same it shall and may be lawful to  
and for the said James H Randolph peaceably and quietly to hold use  
occupy possess and enjoy all and singular the premises above granted  
and released and every part thereof with the appurtenances and to  
have receive and take the rents issues and profits thereof to his  
own particular use and behoof anything herein contained to the  
contrary hereof in any wise notwithstanding. In witness whereof
