For Know all men by these presents Peter F Sudduth Lot That I William K Casley of Greenville District in the State aforesaid for and in consideration of the sum of Two thousand Dollars to me paid by Peter F Sudduth of Greenville District in the State aforesaid have granted bargained sold and released and by these presents do grant bargain sell and release unto the said Peter F Sudduth all that Lot and parcel of land being and being situate on the Pendleton Road about 1/4 miles from Greenville Court House having such bounds shapes as follows Beginning at a Stake 34 on said Road S S Gilliards corner thence with said Road four hundred feet to a Stake 34 thence at right angle with said Road four hundred feet to a Stake 34 on back Street thence with said Street four hundred feet to a Stake 34 on said Street S S Gilliards corner thence with said S S Gilliards line four hundred feet to the beginning corner being the Lot on which I now reside. Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. To have and to hold all and singular the premises before mentioned unto the said Peter F Sudduth his heirs and assigns forever and I do hereby bind myself my heirs Executors and administrators to warrant and forever defend all and singular the said premises unto the said Peter F Sudduth his heirs and assigns against me and my heirs and all other persons whomsoever lawfully claiming or to claim the same or any part thereof
