Whereas by virtue of Writ of Fieri Facias issued out of the Court of Common Pleas held for the District of Greenville tested the Eighteenth day of April in the year of our Lord one thousand eight hundred and fifty three at the suit of Jones & Thomason & others to me directed commanding me that of the goods and chattles lands and tenements of J D Childers to levy the sum of Ninety Dollars damages and cost I have seized and taken of the lands and tenements of the said J D Childers all that certain piece parcel and tract of land containing ninety acres situate and being in the District of Greenville adjoining lands of Inoc Westmoreland James Gault and Robert Bruce & others. And whereas the said premises with their appurtenances since the seizure by me made by virtue of the said Writ of Fieri Facias before mentioned have been exposed to sale at public Vendue and purchased by James Gault of the District of Greenville for the sum of Two hundred and fifty five dollars being the highest sum that was bidden therefor Now know ye that I W A McDaniel Sheriff aforesaid by virtue of the said writ of Fieri Facias aforesaid to me directed and delivered as aforesaid and by virtue of the Statute in such cases made and provided and for and in consideration of the said sum of Two hundred and fifty dollars to me in hand paid or secured to be paid by the said James Gault the receipt and payment whereof I do hereby acknowledge have granted bargained and sold and by these presents do grant bargain and sell unto the said James Gault his heirs and assigns forever the said tract piece and parcel of land with its appurtenances and all the estate right title and interest which the said J D Childers of right had of in and to the same To have and to hold the said piece parcel and tract of land with its appurtenances unto the said James Gault his heirs and assigns forever as fully and absolutely as I the said W A McDaniel might could or ought to grant bargain and sell the same by virtue of the Statute aforesaid. and the said writ of Fieri Facias or otherwise In witness whereof I the said W A McDaniel have hereunto set my hand and seal the Fifth day of March in the year of our Lord One thousand eight hundred and fifty five
