 State and District the receipt whereof is hereby acknowledged have
 given granted bargained sold released and conveyed and by
 these presents do grant bargain sell release and convey unto
 him the said Jeremiah Phillips a certain tract or parcel of land
 situate lying and being in the State and District aforesaid
 on the head waters of Meedy River about eight miles from the
 town of Greenville and bounded as follows, Viz, beginning on a
 pine on the line of said Phillips land running thence South 21
 degree East 10 chains fifteen links to a stake 3/4 thence N 87 1/2 E 29
 chains to a stake on Doctor Willhouses line thence North 21 W 16 chains
 to a red oak 3/4 thence South 81 West 27 chains 50 links to the beginning
 containing thirty five and three fourth acres the the same more
 or less to have and to hold the above granted premises unto him the
 said Jeremiah Phillips his heirs and assigns forever, Together with
 all and singular the rights members hereditaments and appurtenances
 thereto belonging or in any wise incident or appertaining, And
 I the said Zion of Green do hereby bind my self my heirs executors
 and administrators and assigns forever to warrant and defend
 the above premises unto him the said Jeremiah Phillips his heirs

 and three fourth acres be the same more or less, to have and to hold
 the above granted premises unto him the said C C Montgomery his
 heirs and assigns forever, Together with all and singular the rights
 members hereditaments and appurtenances, then unto belonging
 or in anywise incident or appertaining and I the said Jeremiah Phillips
