 of January in this year of Our thousand
 A M Peden Trust Eight hundred and sixty between Robert
 Peden of the District of Greenville
 and the State of South Carolina of the first part and
 Andrew Mc Peden of the same place of the second part
 Whereas the said Robert Peden is desirous to make provisions
 for his grand children Robert Alexander Fowler John Thomas Fowler
 James Wilson Fowler Andrew Martin W Fowler David Simpson Fowler
 Mary Jane Fowler and Nancy J Fowler the seven children of my
 daughter Elizabeth Ann Fowler. Now this indenture witnesseth
 that I the said Robert Peden in consideration of the love and
 affection I had for my daughter and which I bear to her
 children hath given and by these presents do give unto the
 said party of the second part Seventeen hundred dollars in money
 in trust however for the use and benefit of my said Grand
 children above named, and the said trustee or his successors
 is hereby directed to put the above amount of seventeen hundred
 dollars at interest and when the oldest child shall arrive
 at the age of twenty one years to pay him his distribution
 share and when the second child shall have arrived at the
 same age to pay him and so on until the youngest shall have
 arrived to the age of twenty one years if any of the said children
 should die without issue before they are of age then his or her part
 to be equally divided among the surviving children but if the
 child or children so dying leave any issue then the part that
 would have been coming to such parent if alive to be paid
 to his or her children.

 State aforesaid for and in consideration

of the sum of Twelve hundred & fifty Dollars to me in hand paid
 by Andrew Mc Peden of the same place have granted bargained sold
 and released unto the said Andrew Mc Peden all that parcel or tract
 of land containing One hundred & fifteen more or less Situate and
 lying in the State and district aforesaid on South Rabun
 Creek, beginning on a Sweet Gum 3+ on said Creek and running
 thence S 85 1/2 W 17.25 to a Stake 3+ thence S 8 1/4 W 22.80 to Post oak 3+ thence
 S 43 3/4 W 9 to a Stake 3+ on a small creek thence down
 said creek S 61 E 8.10 to a Stake 3+ thence S 86 E 22.30
 to a Stake 3+ thence S 14 E 11.40 to a Stake 3+ on the Creek
 thence up the meanders of said Creek to the beginning
 corner. Together with all and singular the rights mem-
 bers hereditaments and appertinances to the same
 belonging or in anywise incident or appertaining to
 have and to hold all and singular the said premises
 unto the said Andrew M. Peden his heirs and assigns
 forever. And I do hereby bind myself my heirs Executors
 and administrators to warrant and forever defend all
 and singular the said premises unto the said Andrew
 M. Peden his heirs and assigns against myself and
 my heirs and against every other person whomsoever
 lawfully claiming or to claim the same or any part
