and Sixty between Manda Bradley now Manda Stephens the wife of W W Stephens of the State aforesaid and County of Cobb of the one part and Joel E Morris of the State aforesaid and County of Cobb of the other part witnesseth that the said Manda Bradley now Manda Stephens the wife of W W Stephens for and in consideration of Fifty dollars to them in hand paid at and before the sealing and delivery of these presents the receipt whereof is hereby acknowledged hath granted bargained sold and conveyed and doth by these presents grant bargain sell and convey unto the said Joel E Morris his heirs and assigns all that tract or parcel of land lying and being in Greenville District South Carolina containing three hundred acres more or less it being one fifth part the same and said land being that given by Israel Miller to Rebecca Bradley and her children the said Manda Bradley now Amanda Stephens the wife of W W Stephens being one of her children the said Land lying on Enore River and Brush Creek, To have and to hold said tract or parcel of land unto him the said Joel E Morris his and assigns together with all and singular the rights member and assumptions thereto the same in manner belong to his own proper use benefit and behoof in fee simple and the said Manda Bradley now Manda Stephens the wife of W W Stephens for their heirs executors and administrators the said bargained premises unto the said Joel E Morris his heirs and assigns will warrant and forever defend the right and title therof against the claim against all other persons whomsoever.
