 to a Stake $\frac{3}{4}$ thence N 60 W 46.84 to a pine $\frac{3}{4}$ thence west 9.90
 to a Stake $\frac{3}{4}$ thence S 17 W 57.60 to a Stake $\frac{3}{4}$ thence N 79 E
