John Grogan Spencer Hooker	To Mortgage	The State of South Carolina This Indenture made the Eighth day of March in the year of our Lord One thousand eight hundred and sixty One between John Grogan of Greenville District of the One part and Spencer Hooker of Greenville District of the other part. Witnesseth Whereas the said John Grogan is indebted to the said Spencer Hooker the sum of Twelve Hundred and Sixty Five Dollars by two sealed Notes one dated 8 <sup>th</sup> March 1861 for Five Hundred Dollars and due the 1 <sup>st</sup> of August 1861 and one Note dated 8 <sup>th</sup> March 1861 for Seven Hundred and Sixty five Dollars due the 1 <sup>st</sup> day of January 1862 the said two Notes being for the purchase money of a tract of Land sold this day by Spencer Hooker to John Grogan. Now this Indenture witnesseth that the said John Grogan for and in consideration of the premises aforesaid and also in consideration of the sum of Five dollars to the said John Grogan by the said Spencer Hooker in hand paid at and before the sealing and delivery of these presents have granted bargained sold and released and by these pres- ents do grant Bargain sell and release unto the said Spencer Hooker All that piece parcel and tract of land situated in Greenville District on both sides of Mountain creek waters of Enoree River Beginning on a Dogwood 3+0 thence N 65 <sup>1/4</sup> W 45 to a chestnut 3+0 thence N 34 <sup>1/4</sup> E 13.52 to R O 34 thence S 57 <sup>1/4</sup> W 3 07 to a poplar 3+0 thence up the meanders of long branch N 75 W 20.60 to a chestnut 3+0 thence S 94 <sup>1/4</sup> E 23.07 to a poplar 3+0 by Mountain Creek thence down said creek N 60 <sup>1/2</sup> E 3.53 to a W 03+0 thence S 83 <sup>1/4</sup> E 23.23 to B Sack 3+0 thence S 80 W 3.62 to R O Stump 3+0 S 34 <sup>1/4</sup> E 14.50 a pine Stump 3+0 thence N 29 <sup>1/2</sup> E 23.12 to a stone 3+0 thence S 2 E 1.25 to a stone 3+0 thence S 86 E 5.40 to a P O 3+0 thence N 20 <sup>1/2</sup> E 30.27 to the beginning containing One hundred and fifteen acres more or less and the same tract of land conveyed to me by Spencer Hooker by deed bearing even date with these presents Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining, to have and to hold all and singular the premises before mentioned unto the said Spencer Hooker his heirs and assigns forever and I do hereby bind myself my heirs executors and administrators to warrant and forever defend all and singular the said premises unto the said Spencer Hooker his heirs and assigns against me and my heirs and against every person whomsoever lawfully claiming or to claim
