 presents do grant bargain sell and release unto the said  
 John Watson Junr all that tract or parcel of Land situate  
 lying and being in Greenville District and State aforesaid  
 on both sides of Rocky Creek of Enoree River Beginning  
 at a Black Gum 3x3+ on a Branch of Rocky Creek and runs  
 N 1/2 W 2.05 to a Post oak 3x3+ thence N 34 3/4 E 9.22 to a Red oak  
 3+3+ thence N 63 E 11.30 to Pine 3+3+ thence N 67 1/2 E 16.35 to a Stone  
 3+ thence S 53 3/4 E 15.00 to a Stone 3+ near the said creek thence  
 N 10 3/4 E 24.90 to Stone 3+ in place of Post oak gone, thence N 77 1/2  
 W 11.90 to Stone 3+ near a branch of Rocky Creek Horn & Beam  
 gone thence S 8 E 3.30 to Stone 3+ on a Ditch, thence N 82 1/4 W 73.20  
 to Stone 3+ by Chestnut 3+ dead, thence N 77 1/2 W 17.25 to a Hickory
