Know all men by these presents that I Daniel McKinney of Greenville District in the State aforesaid for an inconsideration of the sum of Six Hundred Dollars to me paid by William McKinney Sr of Greenville District and in the State aforesaid have granted bargained sold and released and by these presents do grant bargain sell and release unto the said William McKinney Sr all that certain piece parcel and tract of land lying and being in the District and State aforesaid on Meadow Fork Creek waters of Mush Creek adjoining lands of William McKinney Sr Daniel McKinney and H P Forrest Beginning on a red oak sprout near or on the old original line between Daniel McKinney and William McKinney Sr running S 14 3/4 E 28.80 ch to a apple tree. Thence S 14 1/4 W 18.00 ch to a stone on the Rutherford Road near H P Forrest House thence with said road N 83. W 8.30 ch to a stone on the Holly line thence with said line N 20 W 28.80 ch to a stone. Thence N 41 1/4 E 23.19 ch to the beginning corner containing **Sixty** acres by estimation be the same more or less. Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining. To have and to hold all and singular the premises before mentioned unto the said William McKinney Sr his heirs and assigns for ever and I do hereby bind my self my heirs executors and administrators. to warrant and forever defend all and singular the said premises unto the said William McKinney Sr his heirs and assigns against me and my heirs and against all other persons whomsoever lawfully claiming or to claim the same or any part thereof As witness my hand and seal this 14<sup>th</sup> day of January One thousand eight hundred and sixty two
