and situated in Greenville District State aforesaid containing  
One Hundred and three and half acres more or less and  
runs as follows, beginning on a Red Oak 3+ and running  
S 32 1/2 E 19.00 to a Pine 3+ thence S 44 W 24.25 to a Span Oak 3+  
thence S 59 W 9.00 to Stake 3+ thence S 12 W 29.0 to Stake 3+ thence  
S 44 W 3.40 to B. O 3+ thence N 58 3/4 W 29.75 to a dogwood thence  
N 55 E 50.00 to the beginning and bounded by lands owned  
by Ezekiel Vinson's Estate of Chastain Miram Coody and
