 released and by these presents do grant bargain sell and
 release unto the said M. J. Dickey a certain tract or parcel
 of land lying in State & District aforesaid on Mattaw Creek
 adjoining lands of J. R. Allender Tucker & J. R. Bowden
 beginning at a Hickory on the side of the road and running
 S 61 West 13.40 to a Red oak thence S 14 W 10.60 to a Stake
 or Stone thence S 57. E 17.60 to Post oak Bush on the side
 of the road. thence S 1/2 E 15 with the road to the beginning
 Hickory corner containing Fifteen Acres more or less
 Together with all and singular the rights members
 hereditaments and appurtenances to the said premises
 belonging or in any wise incident or appertaining
 to have and to hold all and singular the premises here
 mentioned unto the said M. J. Dickey his heirs and assigns
 forever. and I do hereby bind my self my heirs executors
 and administrators to warrant and forever defend
