To have and to hold all and singular the premises before mentioned unto the said L D McMakin his heirs and assigns for ever, and I do hereby bind my self my heirs executors administrators to warrant and forever to defend all and singular the said premises unto the said L D McMakin his heirs and assigns forever against me and my heirs claiming the same or any part thereof.

District aforesaid for and in consideration of the sum of ninety nine Dollars to me in hand paid by Blake Carlton of the same State and District have bargained sold and released and by these presents do bargain sell and release unto the said Blake Carlton a certain tract or parcel of land containing nineteen acres being a part of James H. Shell's land beginning on a P.O 3+3+ now on the south side of the road running from J. H. Carlton to Andrew Odams running S 27 1/4 E 37.10 chs to a Stake on the edge of the road running from Double Spring Meeting house by said Carltons & Sandy Goodlitts, thence S 65 W 11.82 chs to a B.C. 3+ now thence N 67 1/2 W 33.15 chs to the begining corner together with all the rights members hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining to have and to hold all and singular the premises before mentioned unto Blake Carlton him his heirs and assigns forever and I do bind my self my heirs executors and administrators to warrant and forever defend all and singular the said premises unto the said Blake Carlton his heirs and assigns against my self my heirs and assigns and against every other person or persons whomsoever lawfully claiming
