 To For Greenville District
 Rev J Barnwell Campbell Lot

Know all men by these presents that I Daniel P Sparks of Greenville District & State aforesaid, but now of the State of Louisiana in consideration of the sum of Four thousand and five hundred Dollars to me paid by Rev J Barnwell Campbell have granted bargained sold & released & by these presents do grant bargain sold & release unto the said J Barnwell Campbell all that lot or parcel of land situate in the town of Greenville District aforesaid containing two acres more or less having the following lines metes & bounds, Viz, beginning at a stake opposite R McKays residence formerly Dr Atwoods on Buncombe Street & a street running down to Vardny McBees residence & running thence with said last mentioned street south 17 west three hundred feet to a stake 34 thence N 38 W five hundred & forty eight & one half feet to a stake on Mrs Parkers line thence N 55 E two hundred and forty seven feet with Mrs Parkers line to a stake on Buncombe Street thence S 38 E two hundred and seventy three & one half feet to the beginning corner being a part of a lot conveyed to Dr Rutherford by V McBee & by said Dr Rutherford to C R Switty & by the said C R Switty to the said Daniel P Sparks together with all & singular the rights, members, hereditaments & appurtenances to the said premises belonging or in any wise incident or appertaining. So have & to hold all and singular the premises before mentioned unto the said J Barnwell Campbell his heirs and assigns forever. And I do hereby bind myself my heirs executors and administrators to warrant & forever defend all & singular the said premises unto the said J Barnwell Campbell his heirs and assigns against me & my heirs & against every person whosoever lawfully claiming or to claim the same or any part thereof.
