 to me paid by William A Hammett of the State and District  
 aforesaid have granted bargained sold and released and by  
 these presents do grant bargain sell and release unto the  
 Said W A Hammett his heirs Executors and assigns for  
 Ever a certain portion or tract of Land containing Sixty Acres  
 more or less situated in the State and District aforesaid on the  
 South Side of Buck horn Creek waters of Moore River adjoining  
 Lands of J B Roseman Cauble Taylor and Bridges bounding  
 as follows beginning on a P O near the road thence East to  
 Rock pine down, thence S 79 E 7 R. O. + thence N 34 E 8.50 to a Black  
 gum thence S 73 E 13.85 black gum thence N 10 E 15.50 to Red oak  
 thence N 73 W 27 small R. O dead thence S 17.55 to a pine on the  
 Road thence with the said Road to the begining P oak corner  
 Together with all and singular the rights members hereditaments  
 and appertinances, To have and to hold all and singular the  
 said premises aforesaid unto the said W A Hammett his heirs  
 assigns forever and I do hereby bind my self my heirs executors  
 administrators assigns to warrant and forever defend all and  
 singular the premises aforesaid unto the said W A Hammett  
 his heirs and assigns against my self my heirs assigns and  
 against every other person or persons whomsoevers lawfully  
 claiming or to claim the same or any part thereof
