that I James L Hudson of the District and State aforesaid for and in consideration of the sum of Two thousand five hundred dollars to me in hand paid by Thomas A Holtzclaw of the District and State aforesaid the receipt whereof I do hereby acknowledge have granted bargained sold and released and by these presents do grant bargain sell and release unto the said Thomas A Holtzclaw all that tract or parcel of Land situate lying and being in the District and State aforesaid on the waters of Rocky Creek water of Enoree River adjoining lands of W Riley Smith J D Smith Wiley King Mathew Hudson and others beginning on a Sweet gum 3+ on Rocky Creek and running thence N 12 W 33.75 chs to a Red oak 3+ thence N 81 West 9.50 chs to a post oak 3+ thence N 65 W 9.50 chs to a Red Oak 3+ thence N 61 W 11.00 to a Stone 3+ thence S 51 1/4 W 29.58 chs to a Hickory 3+ thence S 23 1/4 E 10.76 chs to a Stone 3+ thence S 38 E 17.44 chs to a Pine 3+ thence S 50 E 12.06 chs to white oak 3+ on the Bank of the said Rocky Creek thence down the meanderings of the said Creek thence down the meanderings of the said Creek to the Beginning and which is more fully shown by a Plat herunto attached containing One thousand and eighty five and one half acres with the Exception of one half acre around the Grove yard where my Father Jno W Hudson was buried the same being more or less.
