B C Montgomery	Land

This indenture made the Fourteenth
day of May in the year of our
Lord one thousand eight hundred

and sixty three between William M Thomas Esq^r com-
missioner of the Honorable Court of Equity for Greenville
District at Greenville Court House in the said State of the one
part and Chavis C Montgomery of the other part
Whereas Georgia Turpin on or about the Twenty third day
of March in the year of our Lord one thousand eight
hundred and sixty three exhibited her bill of complaint
in the court of Equity at Greenville Court House in the said
State against Anna Turpin and others for the partition of land
of Joseph M A Turpin deceased. And the cause being at issue
before the Honorable Court came on to be heard at Chambers
in the year of our Lord one thousand eight hundred and
sixty three when the said Court after full hearing thereof, and
mature deliberation in the premises did order, adjudge and
decree that said land should be sold at Public Auction
by the Commissioner of the said Court on the terms and for
the purposes mentioned in their decretal order as by reference
thereto in the registry of the said Court will appear and the
said William M Thomas as commissioner of the said court after
having duly advertised the said Land for sale by public outcry
on the fourth day of May in the year of our Lord one thousand
eight hundred and sixty three did then openly and publicly
and according to the custom of auctions sell and dispose of the
said Land below described unto the said Chavis C Montgomery
for Seventeen Hundred Dollars being at that price the highest
bidder for the same. Now therefore this Indenture witnesseth that
the said William M Thomas as commissioner of the said Court
under and by virtue of the said Decree and in consideration
of the sum of Three Dollars paid him by the said Chavis C
Montgomery the receipt whereof is hereby acknowledged hath
granted bargained sold and released and by these presents
doth grant bargain sell and release unto the said Chavis C
Montgomery and his heirs and assigns all that tract or parcel
of land situate lying and being in Greenville District on water
which are branches of Enoree River containing Two hundred
and forty two acres adjoining lands of Estate of J M A Turpin
and others commencing at a P O dead, S^t N 82 E 50 Stake S^t N 82
W 38, P O S^t 0 L 37 W 39, Rock S^t 0 N 62 W 60 to the begining dead, P O com-
