Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in any wise incident and appertaining. To have and to hold all and singular the premises before mentioned unto the said William F Lester Archibald H Lester and George W Lester as copartners as aforesaid and to their heirs and assigns forever, and I do hereby bind my self and my heirs executors and administrators to warrant and forever defend all and singular the said premises unto the said William F Lester Archibald H Lester & George W Lester as copartners as aforesaid and to their heirs and assigns against me and my heirs lawfully claiming or to claim the same or any part thereof
