Together with all and singular the rights members hereditaments & appurtenances to the said lot of land belonging or in anywise incident or appertaining. To have & to hold all & singular the premises before mentioned unto the said Joseph McClellon his heirs & assigns forever, and I do hereby bind myself, my heirs executors & administrators to warrant & forever defend all & singular the said premises unto the said Joseph McClellon his heirs & assigns against me & my heirs & against every person whomsoever lawfully claiming or to claim the same or any part thereof. Witness my hand & seal this the thirteenth day of May in the year of our Lord one thousand eight hundred and sixty three & in the Eighty seventh year of the Sovereignty & Independence of the State of South Carolina
