Have granted bargain sold and released and by these presents do grant bargain sell and release unto the said Edward Powell Stephen Powell and John W Bolling a certain piece parcel or tract of land containing seven by eight acrus and one quarter be the same more or less. Situate in Greenville District State of South Carolina on the head branches of Deaner Dam Creek branch water of North Saluda River and branches of said River beginning at Rock 3+ n m on the Jones Gap Road formerly the Gap Creek road thence N 80 3/4 E 19.92 chs to Pine 3+ 3+ 0 m dead thence N 63 1/2 E 20.29 chs to rock 3+ 3+ 0 m thence S 22 1/3 W 36.15 chs to Pine Knot Stake 3+ 3+ 0 m thence S 70 1/2 W 8.30 chs Red oak 3+ 3+ 0 m thence N 87 1/3 W 14.79 chs with Cleveland line to Rock 3+ 0 m on the west side of the Gap Creek Road thence along said Road with its meanderings N 37 W 23.40 chs to the beginning rock 3+ n m on said Gap Creek Road.
