Dollars and twenty five cents to me in hand paid by Edward  
Powell Stephen Powell and John W Bolling of the State of South  
Carolina Greenville District. Have granted bargained sold and  
released and by these presents do grant bargain sell and release  
unto the said Edward Powell Stephen Powell and John W Bolling  
a certain piece parcel or tract of land containing Seventy  
Eight acres and one quarter be the same more or less. Situate  
in Greenville District State of South Carolina on the Head branch  
of Deane's Dam Creek branch waters of North Saluda River and  
branches of Said River beginning at Rock 34 n m on the Jones  
Gap Road formerly the Gap Creek road thence N 80 $\frac{1}{4}$  E 19.92 chs  
to Pine 34 34 0 m dead thence N 63 $\frac{1}{2}$  E 20.29 chs to rock 34 34 0 m  
thence S 22 $\frac{1}{3}$  W 36.15 chs to Pine Knob Stake 34 34 0 m thence S 70 $\frac{1}{2}$  W  
8.30 chs Red oak 34 34 0 m thence N 87 $\frac{1}{3}$  W 14.79 chs with Cleveland  
line to Rock 34 0 m on the west side of the Gap Creek Road thence  
along Said Road with its meanderings N 37023.40 chs to the begin  
ning rock 34 n m on Said Gap Creek Road. Together with all and

To have and to hold all and singular the premises before mentioned

their heirs and assigns forever and I do hereby bind myself my heirs  
executors and administrators to warrant and forever defend all and  
singular the said premises unto the said Edward Powell Stephen  
Powell and John W Bolling their heirs and assigns against myself  
and my heirs and against every person or persons whomsoever lawfully  
claiming or to claim the same or any part thereof
