for Rebecca Barton of Greenville District in the State  
aforesaid in consideration of Four Thousand dollars to me  
paid by F A Miles of Greenville District in the State  
aforesaid have granted bargained sold and released and by  
these presents do grant bargain sell and release unto  
the said F A Miles his heirs & assigns all that piece pan  
or tract of land known as the Heightower old place wherein  
Rebecca Barton has resided since the death of her former  
husband John Heightower situated lying and being in Greenville  
on Beaver Dam Creek waters of North Saluda containing  
five hundred and seventy six acres more or less bounded  
by lands of D W Hodges John Goosell Lands belonging to  
the Estate of Alfred Cantrell and others composed of  
several smaller tracts of land and conveyed by the com  
missioner in Equity to the said Rebecca Barton sixth day  
of October A D 1845. Together with all and singular the  
rights members hereditaments and appurtenances to the  
said premises belonging or in any wise incident or appertain  
ing. To have and to hold all and singular the premises  
before mentioned unto the said F A Miles his heirs and assigns  
forever and I as Trustee do hereby bind myself my heirs  
executors and administrators to warrant and forever defend  
all and singular the said premises unto the said F A Miles  
his heirs and assigns against myself and my heirs and  
all other persons lawfully claiming or to claim the same  
or any part thereof
