Know all men by these presents that I Thomas Grisham of the District and State aforesaid for and in consideration of the sum of Fifteen Hundred dollars to me in hand paid by Wm Mc Grisham of Spartanburg District State aforesaid have granted bargained sold and released and by these presents do grant bargain sell and release unto the said Wm Mc Grisham all that tract or parcel of land situated lying and being in the district and State aforesaid on branch waters of Enoree river being a part of the tract of land on which the late William Grisham Senr lived and died beginning on a Red oak 3+ down thence S 51<sup>3</sup>/<sub>4</sub> W 4.41 chains to a Stake 3+ on Dillards corner thence with Dillards line S 24<sup>5</sup>/<sub>17</sub> 91 to a Stake 3+ on thence S 65<sup>5</sup>/<sub>9</sub> 00 to an Alder on the bank of the bank of the creek 3+ thence N 52<sup>5</sup>/<sub>9</sub> 90 to a hickory 3+ thence N 41<sup>3</sup>/<sub>4</sub> 29 30, to a Small Post oak 3+ dead and down, Daniel Woods corner thence with said Woods line N 88 W 5.50 to a Stone 3+ thence a straight line to the beginning corner containing sixty three Acres more or less, bounded by lands of Dillard Woodruff Wood and others, Together with all and singular the rights members hereditaments and appurtenances therunto belonging or in anywise incident or appertaining, I have and to hold all and singular the premises before mentioned unto the said Wm Mc Grisham his heirs and assigns for ever, and I do hereby bind my self my heirs Executors administrators and assigns to warrant and forever defend all and singular the premises before mentioned unto the said Wm Mc Grisham his heirs and assigns against me and my heirs and against every other person or persons, whomsoever lawfully claiming or to claim the same or any part thereof.
