To have and to hold all and singular the premises before mentioned unto the said Margaret L Rose her heirs and assigns forever. And I do bind myself my heirs executors and administrators to warrant and forever defend all and singular the said premises unto the said Margaret L Rose her heirs and assigns against me and my heirs and every other person whomsoever lawfully claiming or to claim the same or any part thereof.

I Alexander Norton of Greenville District and State aforesaid for and in consideration of Seven thousand five hundred dollar to me in hand paid by William Bates of Greenville District and State aforesaid have granted bargained sold and release and by these presents do grant bargain sell and release unto the said William Bates all that tract or parcel of land, Situate lying and being in Greenville District and State aforesaid on branch water of Rudy River, beginning at a Small Post oak 3+3+ and runs S 67 1/2 W 33.00 to a Stone 3+n Red Oak 3+ dead and down, thence N 32 W 1.25 to a Stone 3+ thence S 68 W 26.25 to a Stone 3+ in an old road, thence along said road S 18 E 9.70 to a Stone 3+ in the road, thence S 85 1/2 E 28.25 to a White oak 3+n on the side of a branch, thence down the branch with the meanders 7.60 chains to a Stake in the branch thence N 81 E 9.00
