

Harriet B. McBee Deed, The State of South Carolina
To Greenville District 3 S.S.
Miss M.P. McBee et al.

Whereas in the last will and testament
of my father in law Vardry McBee
deceased but little provisions is made for Miss Melinda P.
McBee and Mrs Martha Carson the daughters of said Vardry McBee
and for the children of Luther M. McBee deceased who are the
grand children of said Vardry McBee and whereas by the said
last will and testament, all of the Estate of the said Vardry
McBee after certain provisions contained in said will is to be dis-
tributed and divided as follows, Viz, one third to Vardry A. McBee
One third to Alexander McBee and the other third between my
self and my children as the widow and children of Wm Pinkney
McBee deceased that is the one third thereof to myself and the
remaining two thirds to be equally divided amongst my children
and whereas whilst expressing my deepest gratitude for the said
liberation of my said father in law towards me and my highest
respect for his memory. I am not willing to receive the said legacy
to the exclusion of the said daughters and grandchildren of the
said Vardry McBee deceased as I regard them to be more entitled
then to in justice and equity than myself and whereas I desire
therefore unsolicited and unadvised and of my own free will and
accord to give to the said daughters and grandchildren of the said
Vardry McBee deceased the entire benefit of the provision which
was made for me in said will. Now therefore know all men by
these presents that I Harriet B. McBee of Greenville District in
the State aforesaid widow of Wm Pinkney McBee deceased in
consideration of the premises aforesaid and in further consid-
eration of the sum of five dollars to me paid by the said Miss
Melinda P. McBee and Mrs Martha A. Carson and the children
of Luther M. McBee deceased have given granted bargained
sold released and conveyed, and by these presents do hereby
give grant bargain sell release and convey unto the said Miss
Melinda P. McBee Mrs Martha A. Carson and the children
of Luther M. McBee deceased all and singular the rights
little interest claim and estate which I have and am
entitled to in the Estate of the said Vardry McBee deceased
by reason of the said legacy to me of one third of that
third portion of the Estate of said Vardry McBee deceased
bequeathed and devised to myself and my children as the
widow and children of Wm Pinkney McBee deceased, so
as to substitute the said Miss Melinda P. McBee Mrs
Martha A. Carson and the children of the said Luther M.
McBee deceased to all my interest under and by virtue
of said legacy. The said legacy and share thus conveyed and
released to them, to be divided and held amongst the said
parties in the following shares and proportions. That is to
say one third part thereof to the said Miss Melinda P. McBee
one third part thereof to the said Mrs Martha A. Carson
and one third part thereof to be divided equally amongst
the children of the said Luther M. McBee deceased.
