 Charleston S. C. Trustee as aforesaid for the benefit of Mrs Emily C
 Hatch all that piece parcel & tract of land containing four hundred
 and fifty acres more or less situated lying and being in the District & State
 aforesaid and having such forms mark and bounds as by reference to
 a plat drawn by J. C. Hoyt Sep. Surveyor and annexed to the conveyance of John
 A. Ledand, Superintendent of Public Works to S. D. Lewis bearing date
 the seventh day of July A. D. 1857 and recorded in the office Register of
 Mesne Conveyance for said District in Book W page 419 & 420 on
 13 September 1844 Together with all and singular the rights
 & appurtenances to the said tract belonging or
 in anywise incident or appertaining. To have and to hold all
 and singular the premises before mentioned unto the said Thos
 P Allen Trustee as aforesaid unto the said Mrs Emily C Hatch
 under the marriage Settlement of Lewis W Hatch & wife and unto
 his assigns forever and I do hereby bind my self my heirs Executors
 administrators to warrant and ever defend all and singular
 the said premises unto the said Thos P Allen in trust as aforesaid
