ation of the love and affection which I bear my son Agariah Woodson & also for his being incapacitated to a considerable extent for the active duties of life by a wound received in the service of his country as a soldier entirely disabling one hand and further in consideration of the sum of thirty dollars to me in hand paid by the said Agariah Woodson the receipt whereof is hereby acknowledged have given granted bargained sold released and conveyed and by these presents do give grant bargain sell release and convey unto the said Agariah Woodson his heirs & assigns Two Parcels or Tracts of Land lying in Greenville District on the East side of Saluda River and containing Fifty Five acres more or less with such marks and boundaries as follows To West, Tract No 1 on which is the homestead begins at a P.O 3+0m thence N62 W11 $\frac{1}{2}$ chains to Stake 3+0m thence N22 E20 chains to Stake 3+0m thence East 5.30 chains to a P.O 3+0m thence N20 E11.20 chains to Pine Stump 3+0m thence S77 E10 chains to Rock 3+0m, thence S12 W13.06 chains to S.O Station and 7 chains to Rock 3+0m in field thence S52 W24 $\frac{1}{2}$ chains to Rock 3 nm thence N22 W4.36 chains to beginning corner bounded by lands of my own and lands of Major A. Mc Hamilton Elijah Eskew &c and containing forty two acres more or less. Tract No 2 lying directly on Saluda River beginning at a Maple 3+nm near a spring, thence N66 $\frac{1}{4}$ W29.30 chains to Rock 3+0m on the bank of Saluda River, thence down the meanders of said River to a Wahoo 3+nm at the mouth of a branch thence up the meanders of said branch to the beginning corner, bounded by lands of my own & Elijah Eskew and containing thirteen acres more or less. Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining to have and to hold all and singular the premises before mentioned unto the said Agariah Woodson his heirs and assigns forever, and I do hereby bind myself my heirs Executors and administrators to warrant and forever defend all and singular the said premises unto the said Agariah Woodson his heirs and assigns against myself and against every person or persons whosoever lawfully claiming or to claim the same or any part thereof.
