 more or less situate lying and being on Laurel creek waters of Needy
 River in the District and State aforesaid and having the following
 lines metes and bounds, Viz, beginning at a Stake 3+ four Corners
 and running thence N 62 E 32.45 to a Stake 3+ new thence N 29 W 37
 14. to a Sassafras 3+ thence S 29 1/2 W down the meanders of a branch
 to a W. O 3+ thence W 2.40 to a black Gum 3+ new, thence S 61 W 25.72 to
 a Stake 3+ new thence S 33 E 36.70 to the beginning, Except about one fourth
 an acre reserved as a gravel yard, said tract of land adjoins lands
 of Pike Hudson et al and was conveyed to me by Elizabeth Pike Ex or
