To have and to hold the above granted premises unto him the said Reubin Sally his heirs and assigns forever together with all and singular the rights members hereditaments and appurtenances therunto belonging including said premises and I the said Thomas Couch do hereby bind myself my heirs executors and administrators and assigns to warrant and forever defend the above mentioned premises against myself my heirs executors and administrators and assigns and against every other person or persons lawfully claiming the same or any part thereof In witness whereof I have hereunto set my name and affixed my seal this day the 21<sup>st</sup> December in the year of our Lord one thousand eight hundred and fifty eight, signed sealed and delivered in presence of Williams Cox
