

Faster Blodgett	Deed	The State of South Carolina
No	For	I know all men by these presents that
the Envix Trust	Lot	I Faster Blodgett of Greenville District

in the State aforesaid in consideration  
of One thousand dollars to me paid by William Envix Trustee  
for Elizabeth Envix and also her consent for the said William Envix  
to go to the Service of the Confederate States as Substitute for S. Blodgett  
of Greenville District in the State aforesaid have granted bargained  
sold and released and by these presents do grant bargain sell and  
release unto the said William Envix Trustee for his Elizabeth Envix  
his wife a certain lot of land lying within or near the corporation  
of the Village of Greenville on the SWest Side of Reedy River and near  
the Greenville & Col R Road on the South Side bounded as follows. To wit  
beginning at a Stake Rays old corner on a Street and runs thence  
with said line S $\frac{1}{2}$  W $\frac{1}{2}$  chains 67 links to a Stake Rays upper corner  
thence N 89 W 2 chs 25 links to a Stake, thence N 9 $\frac{1}{2}$  E 5 chs 67 links  
to a Stake, Stake corner thence along said street S 89 E 2 chs 25 links  
to the beginning corner containing one acre and one rood more or  
less being the lot I purchased of Peter Cauble & A. McKee bearing  
date 31<sup>st</sup> August 1863, for particulars see said deed. Also with  
the right of the Trustee to sell & reinvest the proceeds in real estate  
with her consent giving him the Trustee right to make titles, together  
with all and singular the rights members hereditaments and appur-  
tenances to the said premises belonging or in any wise incident or  
pertaining. To have and to hold all and singular the premises before  
mentioned unto the said William Envix Trustee for Elizabeth Envix  
her heirs and assigns forever, And I do hereby bind myself  
my heirs Executors and administrators to warrant and forever  
defend all and singular the said premises unto the said William  
Envix Trustee for Elizabeth Envix her heirs and assigns against  
me and my heirs and every other person whomsoever lawfully  
claiming or to claim the same or any part thereof.
