Made on this the 24th day of August Anno Domini 1864, by and between Martha E Weaver of the first part Richard H Whelden of the second part & William J Gibson Trustee of the the third part, Whereas a marriage is shortly intended to be solemnized between the said Martha E Weaver & the said Richard H Whelden & upon the Treaty of said Marriage it was agreed between the parties that the whole of the Real & Personal Estate of the said Martha E Weaver should be secured to her in manner hereinafter mentioned Now this Indenture witnesseth that the said Martha E Weaver in consideration of the said intended marriage and of the premises and of one dollar to her in hand paid
