this indenture made the Nin  
teenth day of October in  
the year of our Lord one

thousand eight hundred and sixty three between  
Therdon G Craft of the one part, and Joseph Glover  
of the other part witnesseth, Whereas the said Joseph  
Glover stands indebted to the said Therdon G Craft  
aforesaid by his Bond in the sum of Three Thousand Two  
Hundred Dollars according to the copy endorsed. Now  
this Indenture witnesseth that the said Joseph Glover  
for and in consideration of the said debt or sum payable  
as aforesaid to the said Therdon G Craft aforesaid and  
for the better securing the payment thereof to the said Therdon  
G Craft as aforesaid according to the Bond aforesaid  
and also in consideration of the sum of Three Dollars by him  
the said Therdon G Craft aforesaid to the said Joseph Glover  
in hand paid at and before the sealing and delivery of these pres-  
ents do grant bargain sell alien release convey and confirm  
unto the said Therdon G Craft and to his heirs all that  
tract or lot of land situate lying and being in Greenville  
Town in the District of Greenville and State abovenamed,  
adjoining lots of William Jackson and others on the Rich-  
mond Street or Road and more particularly described in a deed  
of Conveyance from Therdon G Craft to the said Joseph  
Glover bearing date the Sixteenth day October Anno Domini  
Eighteen Hundred and sixty three. Together with all and  
singular the rights members and appurtenances thereto  
belonging or in any wise appertaining and the reversions  
and residues remainder and remainders rents issues and  
profits thereof to have and to hold the said Land with the  
appurtenances unto the said Therdon G Craft and his heirs  
forever Provided always nevertheless and it is the true  
intent and meaning of the parties to these presents that if  
the said Joseph Glover or his heirs executors or adminis-  
trators shall well and truly pay or cause to be paid unto  
the said Therdon G Craft or his heirs or assigns the sum  
of Thirty Two Hundred Dollars according to the Bond  
endorsed and above mentioned then and from thenceforth  
these presents shall be utterly null and void anything herein  
contained to the contrary thereof in any wise notwithstanding  
and it is covenanted and agreed upon by and between the  
parties to these presents that until default shall be made in  
payment of the aforesaid sum as before set forth and the interest  
for the same it shall and may be lawful to and for the said  
Joseph Glover peaceably and quietly to hold use occupy possess  
and enjoy all and singular the premises above granted and released  
and every part thereof with the appurtenances and to have  
receive and take the rents issues and profits thereof to his  
own particular use and behoof anything herein contained  
to the contrary hereof in any wise notwithstanding
