

C J Hammond Deed To W A McConnell	For Lot	<p>The State of South Carolina Know all men by these presents that Charles J Hammond of Greenville District in the State aforesaid in consideration of fourteen hundred and fifty dollars to me paid by William A McConnell of Greenville District in the State aforesaid have granted bargained sold and released and by these presents do grant bargain sell and release unto the said William A McConnell all that piece parcel and lot of land containing three eighths of an acre more or less situate lying and being in the town of Greenville in the District and State aforesaid, and bounded as follows, viz, by Main Street for eighty eight feet on the west by Judge Street for two hundred and twenty four feet on the North by Brown Street for eighty eight feet on the East and by the lot of said William A McConnell for two hundred and twenty four feet on the South it being a part of lots 30 32 and 35 N E Section of said town conveyed to me by Moses Green by deed of 25 February 1852 together with all and singular the rights members hereditaries rights and appurtenances to the said premises belonging or in any wise incident or appertaining, to have and to hold all and sing ular the premises before mentioned unto the said William A McConnell his heirs and assigns forever, and I do hereby bind my self my heirs executors and Administrators to warrant and forever defend all and singular the said premises unto the said William A McConnell his heirs and assigns against me and my heirs and every other person whatsoever lawfully claiming or to claim the same or any part thereof witness my hand and seal this 16th day of October in the year of our Lord one thousand eight hundred and sixty five and in the 90th year of the Independence of the United States of America Signed sealed and delivered in the presence of of G G Wells of Elyford</p>
