To For
George Heldman Lot

Vnow all men by these presents
that I Vardry McBee of Greenville
District in the State aforesaid in
consideration of three thousand six hundred and twenty five
Dollars to me paid by George Heldman of Greenville District
in the State aforesaid have granted bargained sold and
released and by these presents do grant bargain sell and
release unto the said George Heldman all that Lot of Land
in the Village of Greenville on the South East corner of Main
and Broad Street Commencing on Main Street and runs along
said Street South 16 West One hundred and forty feet, thence
at right angles with Main St South 74 E One hundred and
seventeen and one half feet to said lot thence North 16 E One
hundred and forty feet to Broad Street, thence along Broad Street
North 74 West One hundred and seventeen and a half feet to the
beginning being the same lot that the said Heldman has had
on for several years, together with all and singular the rights
members hereditaments and appurtenances to the said premises
belonging or in any wise incident or appertaining. To have
and to hold all and singular the premises before mentioned unto
the said George Heldman his heirs and assigns forever, and I
do hereby bind myself my heirs executors and administrators to
warrant and forever defend all and singular the said premises
unto the said George Heldman his heirs and assigns against my
self and my heirs or any other person lawfully claiming or to
claim the same or any part thereof.

of land situated and lying and being within the corporate limits
of Greenville now in my possession and having such shape form mark
butting and boundaries as are set out in the Deed of the Greenville
and Columbia Rail Road Company to John Bellon O'Neal
April 19th 1854, and more recently by Jacob Hester to me by deed
bearing date 9th Sept 1853. To have with all and singular
the rights Members hereditaments and appurtenances to the
said premises belonging or in any wise incident or appertain-
ing. To have and to hold all and singular the premises before
mentioned unto the said G Heldman his heirs and assigns
forever and I do hereby bind myself heirs executors and admi-
nistrators to warrant and forever defend all and singular
the said premises unto the said G Heldman his heirs and
assigns against me and my heirs lawfully claiming or to claim
the same or any part thereof.
