This Indenture made the third day of February in the year of our Lord one thousand eight hundred and sixty nine between Nathan Mc Davis of Greenville County South Carolina of the one part and James Mc Burman of the said State and County of the other part. Whereas the said Nathan Mc Davis is indebted to the said James Mc Burman in the sum of Four thousand Eight hundred and forty seven dollars with interest thereon from the present date by eight several Promissory Notes five for Five hundred dollars each two for one thousand Dollars each and one for three hundred and all payable on or before the first day of February in the year of our Lord one thousand eight hundred and thirty four. Now this indenture witnesseth that the said Nathan Mc Davis for and in Consideration of the premises and also in Consideration of the sum of Five Dollars to the said Nathan Mc Davis by the said James Mc Burman in hands paid at and before the sealing and delivery of these presents have granted bargained sold and delivered by these presents do grant bargain sell and release unto the said James Mc Burman all that piece of land and tract of land situate lying and being in Greenville County South Carolina about three miles North from Greenville Court House on waters of Richland and Limestone Calets value of ready money containing ten thousand and eighty six acres more or less being a part of a tract of three hundred and forty five acres bounded to the said James Mc Burman and B. J. Stanley others in March 1867 and known and can describe from a plat of the whole tract made by G. H. Stark Dec. January 29, 1861 as follows beginning at a large tree 10 ft. of the dwelling house a Spring on the

near a corner of Busell's tract now esp. Rebecca Davis land containing thence 39 1/2 to bounding line of Hammatt's land thence along said line 160 ft to a stone corner thence 139 682 chains to a rock & thence 59 8 32 to a post & thence to the place of big quarry bounded by lands of Burman Hammatt Stanley Roberts and Thompson together with all and singular the Rights Minors & Inconveniences appertaining thereto to the said premises belonging or in anywise incident or appertaining to have and to hold all and singular the premises aforesaid mentioned unto the said James Mc Burman his heirs and assigns forever and I do hereby bind my said Executors and Administrators to warrant and forever defend all and singular the said premises unto the said James Mc Burman and his heirs and assigns against his and my heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof provided always nevertheless and it is the true intent and meaning of the Parties to these presents that if the said Nathan Mc Davis his Executors and Administrators shall will and be by pay or cause to be paid unto the said James Mc Burman the sum of Four thousand eight hundred and forty seven dollars according to the tenor and effect of the Promissory Note aforesaid mentioned there and from thence forth these presents shall be utterly null and void any thing herein contained to the contrary thereof in any wise notwithstanding. And it is covenanted and agreed upon by and between the Parties to these presents that unless default shall be made in payment of the aforesaid sum or before set forth and the interest for the same it shall and may be lawful to and for the said Nathan Mc Davis to quitclaim and quitly to hold and occupy possessed enjoy all and singular the premises above aforesaid and released and every part thereof unto the aforesaid James Mc Burman and to have received and take the rents issues and profits thereof to his own particular use and benefit anything herein contained to the contrary thereof in any wise notwithstanding I in witness whereof the said parties have hereunto set their hands and seals the day and year first above written (the sum of Five Dollars was retained before the execution hereof) sealed and delivered in presence of B.
