Know all men by these presents that we the undersigned have this day divided a tract of land known as the Barton tract situated in the County and State of South Carolina on the banks of Enoree River containing three hundred and fifty one acres more or less upon the following conditions namely that said Marcus R Barton upon his part has agreed to take the portion of land as described by his plat drawn by W A Hudson the 5th day of July 1865 except the house and lot of thirteen acres which is shown on his plat and further agrees to pay the said James G Barton twenty five dollars for the land he has over his proportional part, the said James G Barton upon his part has agreed to take the portion of land as designated by his plat drawn by W A Hudson 5th day of July 1865, and further agrees to pay the said James G Barton One Hundred dollars for the land he has over his proportional part, the said James G Barton upon his part has agreed to take the portion of land as designated by his plat and the house and lot of 13 acres shown on the plat of Marcus R Barton and One Hundred and twenty five dollars his plat was drawn the 5th day of July 1865 by W A Hudson they have agreed to give each other possession of their land by the first day of January 1869 and one is not to interfere with the land of another and do hereby bind themselves at a proper time to give to each other a good and lawful deed to the land above named, the said land at this time belongs to Elizabeth Galloway their mother and willed by Shaphy Barton at her death to her three sons Marcus, George & James

A B Vickers vs J P Bishop	Deed for Land	The State of South Carolina To all whom these presents shall come I A B Vickers Sheriff of Greenville District and State aforesaid send greeting Whereas by virtue of a writ of Fieri Facias issued out of the Court of Common Pleas held for the District of Greenville tested the second day of November in the year of our Lord One thousand eight hundred and sixty seven at the suit of Thomas Lynch to me directed commanding me that of the goods and chattels lands and tenements of Alexander M Kenney to levy the sum of dollars damages and costs I have seized and taken of the lands and tenements of the said Alexander M Kenney all that certain piece parcel and tract of land containing one hundred and eighty five acres more or less situated and being in the District of Greenville in the State aforesaid situated on the waters of Sycamore River adjoining lands of Edwin Spawmell J C Hawkins of Thomas and others and known as the Bankers Place and whereas the said premises with their appurtenances since the seizure by me made by virtue of the said writ of Fieri Facias before mentioned have been exposed to sale at public vendue and purchased by Simpson Bishop of the County of Greenville for the sum of One hundred and sixteen dollars being the highest sum that was bidder therefor now know ye that A B Vickers Sheriff aforesaid by virtue of the said writ of Fieri Facias aforesaid to me directed and delivered as aforesaid and by virtue of the Statute in such case made and provided and for and in consideration of the said sum of One hundred and sixteen dollars to me in hand paid or to be paid by the said Simpson Bishop the receipt and payments whereof I do hereby acknowledge have granted bargain and sold and by these presents do grant bargain and sell unto the said Simpson Bishop his heirs and assigns forever the said tract piece and parcel of land with its appurtenances and all the estate right title and interest which the said Alexander M Kenney of right had in and to the same to have and to hold the said piece parcel and tract
