14.55 to a Stake 3+ thence S 65 E 28.25 to a Stake 3+ bounded by
S 90 Shumate thence N 16 E 24.75 to a Stake 3+ thence N 15 E to
Reedy River at or near the mouth of a branch bounded by the
catast of J C Sullivan decd thence up the meander of said
River about 24 chains to Black Oak 3+ Andrew Ramsey now
William and Young Simms Corner thence N 57 W 49.00 to a
