 Allen Chandler Esq. This agreement entered into between
 Allen McDaniel of the Wanda Mining and Manufacturing Company
 of the one part and Allen Chandler William Allison B. Bagwell
 and Fred Smith planters of Greenville County of the other part
 and of the State aforesaid to-wit that the said Allen McDaniel
 ought as aforesaid agrees to furnish to the said aforesaid named
 parties from time to time during the present year Four Tons and
 Three fourths of the Wanda Fertilizer or other manure such for the
 cultivation thereof as the the said Allen McDaniel agent
 may deem proper not exceeding in the whole four thousand
 lbs to be used by the said aforesaid named parties in the
 cultivation of cotton plantations known as in the county of Greenville
 and State aforesaid or such other plantations as he may author-
 ize the consideration whereof the said Allen Chandler William
 Allison and B. Bagwell and F. Smith does hereby sell transfer
 and assign to deliver to the said Wanda Mining and Man-
 ufacturing Company so much of the cotton or other produce raised
 on said plantations or plantations during the present year
 upon the gathering of said crop or any part thereof as will
 be sufficient to pay or satisfy them for the advances thus made
 which conveyance and transfer is intended to create in
 favor of said Wanda Mining and Manufacturing Company
 the lien given by and under the act of the Legislature
 entitled an act to secure advances for agricultural purposes
 approved and ratified on the twentieth day of September AD
 1868 is intended to be a lien binding the crops raised during
 the present year on said plantations or plantations in preference
 to all other liens or claims existing or otherwise to the extent
 of such advances aforesaid with all the powers rights and
 remedies by the said act provided and it is further agreed
 that the claims for the fertilizer furnished under this agree-
 ment shall be deemed owing at the date of delivery of said
 fertilizer or parts thereof as the same shall be gathered to
 the effect of the value of the fertilizer then furnished and
 that the holding of a draft negotiable note or other security
 shall not suspend the immediate enforcement of the said
 Lien whenever the said Wanda Mining and Manufacturing
 Company may deem it necessary and the said parties
 covenant that they not at any time hereafter given to any
 persons or persons whatsoever any lien upon the crops to be
 raised upon the said plantations or plantations during
 the present year and it is further agreed that the
 said parties aforesaid named will pay interest on the
 value of the said fertilizers at the rate of one per cent
 per month from the date in which said fertilizers is
 furnished in witness whereof we have set our hands

 send greeting whereas I the said Martha A. Carson in and
 by a certain Bond or obligation bearing date the sixth day of
 June in the year of our Lord one thousand eight hundred
 and seventy stands firmly held and bound unto Martha McCall
 of Greenville County and State aforesaid in the sum of one
 thousand Dollars together with interest on the said sum
 at the rate of ten per centum per annum payable semi-annually
 as in and to the said Bond or obligation reference being
 thereunto had will more fully appear for which I the said
 Martha A. Carson in consideration of the said debt
 and sum of money aforesaid and for the better securing the payment
 thereof to the said Martha McCall and also in consideration of
 the further sum of Two Dollars to me the said Martha A. Carson
 in hand well and truly paid by the said Martha McCall
 at and before the reading and the signing of these presents the
 receipt whereof is here by determined and granted bargained
 sold and released and by these presents do grant bargain sell
 and release unto the said Martha McCall all that piece parcel
 and tract of Land known as the New Ward situated lying
 and being in the County of Greenville and State aforesaid
 in the City of Greenville containing four acers more or less
 described in the writ of Partitions of the Estate of Tandy
 McRee deceased as part of said land more fully described
 in the returns of the Commissioners to the said writ and
 the Plat attached thereto and being the same tract conveyed
 by James P. Moore Commissioner in Equity to me Martha
 A. Carson also all that tract of land containing eight
 hundred acres more or less situated lying and being in the
