Green all my right title estate and interest being the undivided one half thing of in or to all that piece parcel and Lot of Land situated being in the City of Greenville and County of Greenville and State of South Carolina and having the following line to wit Beginning on corner of Main Cross Street and Canal Street in said city and running thence S 16 W 200 feet to a stake thence N 74 E 200 feet to stake thence N 16 E 200 feet to a stake thence S 74 E 200 feet to the Beginning and all my right title estate and interest being likewise the undivided one half thing of in or to all that other piece parcel and Lot of Land situated being and being in the said city and County of Greenville and State of South Carolina adjoining the lot of above described and bounded per Jackson and Brown Street beginning on Jackson Street on corner of lot above described and running on Jackson Street 93 feet to Broad Street 84 thence on Broad Street N 74 W 100 feet to a stake thence N 16 E 100 feet to a stake on line of lot above described and thence with said line 100 feet to the beginning on Jackson Street the property above described being the undivided one half of the property conveyed to me by John L. Motters of Georgia by deed bearing date the eighth day of January one thousand eight hundred and sixty nine the other undivided half thereof having been conveyed to the said John N. Green by me by deed bearing date the seventeenth day of February one thousand eight hundred and sixty nine together with all and singular the rights members hereditaments and appertinances to the said premises belonging or in anywise incident or appertaining to have and to hold all and singular the premises before mentioned unto the said John N. Green his heirs assigns forever and I do hereby bind my self and my heirs executors and administrators by covenant and forever defend all and singular the said premises unto the said John N. Green his heirs and assigns against me and my heirs and assigns and against every other person whomsoever lawfully claiming the same.
