 Air Line Railway Company and its successors and assigns  
 all the land contained within one hundred feet in width  
 on each side of the track or roadway Measuring from  
 the center of any portion of the lot of land aforesaid  
 described through which said Railroad may be constructed  
 run and operated The land hereby conveyed being cut off  
 and a portion of a certain piece parcel or tract of land  
 situated in the County and State aforesaid and about one  
 and one half mile from Greenville County Line and  
 known as my farm Provided Law entitled to the word  
 on the land that the said Railway Company shall keep  
 always the Cattle Grazed in good repair at whatever parts
