 Dollars to me in hand paid by James Nesbitt of Spartanburg District
 and State aforesaid have granted bargained sold and released and by these
 presents do grant bargain sell and release unto the said James Nesbitt all
 that tract or parcel of Land situate lying and being in Greenville District
 and State aforesaid on the South side of South Tyger River and on both sides
 of Long Branch beginning at a stone 3x formerly Hickory on the bank
 of old River bed and running thence S 43 1/2 W 25 1/2 to a Stone 3x Red Oak
 head and down thence S 87 1/2 E 19 1/2 to the edge of Mill Pond on Long Branch
 thence up Mill Pond covering so much Land as may be necessary for
 Mill Pond privilege and thence up Long Branch to a Stone 3x Pine dead
 and down thence S 1 1/2 E 35 or to a Stone 3x Red Oak dead and down thence
 S 53 1/2 E 72 1/2 to a Stone 3x Pine 3x thence S 85 1/2 to Stone 3x in an old road thence
 S 55 1/2 W 20 1/2 to a Stone 3x in the same old road thence N 85 E 31 1/2 to a pole
 3x at the head of a branch thence down said branch to a long Pole 3x
