This Indenture made the nineteenth day of February in the year of our Lord One thousand eight hundred and seventy four between Paul W Shofford of the City County and State of New York of the first part and Susan Shofford Executrix of and trustee under last will and testament of Paul Shofford deceased of the same place party of the second part & witnesseth that the said party of the first part for and in consideration of the sum of ten Dollars lawful money of the United States of America to him in hand paid by the said party of the second part at or before the ensaing and delivery of these presents the receipt whereof is hereby acknowledged hath granted bargained sold aliened remised released convey ed and confirmed and by these presents doth grant bargain sell alien remise release convey and confirm unto the said party of the second part and to her heirs successors and assigns for ever all that certain tract or parcel of land lying and being in the County of Greenville State of South Carolina bounded as follows to wit Beginning at a stake on the Pinecomb road Languans corner and running thence with the Pinecomb road N 37° W 7 chains 9 links to a stake at W McBees line thence with McBees land S 53° W 11 chains 16 links to a stake thence with M. Bees and Languans land N 53° East 11 chains and 16 links to the beginning corner being the same tract of Land con veyed to said Paul W Shofford by J G Martin trustee also another tract lying and being in said County and State on Long branch of Reedy River and bounded as follows to wit Beginning at a stake 3x formerly R 0 3x and running thence N 54° W 6 chains 3 links to a stake by a R 0 thence W 35° E 7 chains and 50 links to a stake 3x thence N 54° W 13 chains 30 links to a stake on a branch on Allstons line thence with said line across the branch N 35° E 10 chains 20 links to a stake 3x Allstons corner thence S 76° East 12 chains to a stake 3x thence S 17 1/2° W 24 chains to the beginning containing twenty and one half acres be the same more or less Together with all and singular the ten ments hereditaments and appurtenances therunto belonging or in anywise appertaining and the reversions and reversions remainder and remainants rents issues and profits thereof And also all the estate right title interest property possession claim and demand whatsoever as well in law as in equity of the said party of the first part of in or to the above described premises and every part and parcel thereof with the appurtenances I have and to hold all and singular the above mentioned and described premises together with the appurtenances unto the said party of the second part her heirs successors and assigns And the said Paul W Shofford for himself his heirs executors and administrators doth covenant promise and agree to and with the said party of the second part her heirs successors and assigns that he has not made done committed executed or suffered any act or acts tending
