in the State aforesaid in consideration of the sum of Sixteen hundred Dollars to me paid by Miles R. Beeco of Greenville County in the State aforesaid have granted bargained sold and released and by these presents do grant bargain sell and release unto the said Miles R. Beeco all those two pieces parcels and Lots of Land situate lying and being in the said County and State in the City of Greenville on the east side of Jail Street having the following lines notes and bounds to wit Lot No 1 Beginning at the corner of Jail street, and on Alley thence along Jail street S 1/4 W about one hundred feet to the corner of a piece of Land sold to Peter Leuble, Thence from said corner S 74 E One hundred and seventy six feet to a stake Thence N 1/4 E to a line with said Alley thence along that line to Jail street the beginning corner being the said lot of Land conveyed to John Markley by Jesse Dean by Deed of October 20th 1838 also the balance of Lot No 2 belonging to the said Wm A Jennings Together with all and singular the Rights Members hereditaments and Appurtenances to the said premises belonging or in any wise incident or appertaining, To have and to hold all and singular the premises before mentioned unto the said Miles R.
