Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining to have and to hold all and singular the premises before mentioned unto the said John Adams his heirs and assigns forever And I do hereby bind myself my heirs executors and administrators to warrant and forever defend all and singular the said premises unto the said John Adams his heirs and assigns against myself my heirs and every other person or persons lawfully claiming the same or any part thereof As witness my hand and seal the fourteenth day of February in the year of our Lord One thousand eight hundred and seventy four
