The State of South Carolina Know all men by these presents that I Peter L Snyder of Greenville County and State aforesaid in consideration of the love and affection I have and bear for my children and in consideration of the sum of five Dollars to me paid by my wife Elizabeth Sarah Snyder have granted bargained sold and released and by these presents do grant bargain sell sell and release unto the said Elizabeth Sarah Snyder all that tract and plantation of land situated lying and being in Greenville County aforesaid on the Stanton bridge road about four Miles from the City of Greenville commencing at a Spanish Oak 3x on said road running thence S 69 E 22.40 to a black gum 3x thence N 21 E 27 to a stake 3x thence N 69 W 8.20 to a black gum 3x on the said Stanton bridge road thence S 44 1/4 W 12.20 to a bend in said road thence S 62 1/4 W 14.25 to another bend in said road thence S 21 1/2 W 5.40 to the beginning corner the line running in the middle of said road from the black gum corner being the same tract of land conveyed to me by Wm E Earle by deed bearing date November 19 1871 now on record said land being bounded by lands of Clayton Thompson Wm Plythe Ambrose Smith and Ambrose Cobb and containing forty Acres more or less together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining In trust nevertheless for my children Elizabeth Snyder Bessie Snyder Jessie Snyder Sizzie Snyder and Anadella Snyder and in trust also for any children hereafter born of the marriage of myself and my said wife with power hereby given to the said trustee to manage said land for the common support and benefit of my said children and after paying all annual taxes and expenses of managing said premises to apply the yearly proceeds or rents or profits of the same to the purposes aforesaid until the young of the said children shall be of legal age and then to pay the same to the said children or their heirs and assigns forever
