A. Austin D. S. Therewith attached Together with all and singular the hereditaments Rights, members, and appurtenances whatsoever to the said Tract of Land belonging, or in anywise appertaining; and the Reversions and remainders Rents, Issues and profits thereof; and also all the estate, Right, title, interest, Power, possession, property, benefit, claim, and demand whatsoever both at Law and in Equity; of the heirs and representatives of the said James Locke and of the parties to this Suit, and of all other persons rightfully claiming, or to claim the same, or any part thereof, by, from or under them, or either of them, to have and to hold the said Tract of Land with its Hereditaments, privileges and appurtenances unto the said Mrs Isabella Locke her heirs and assigns, to her and their only proper use, benefit, and behoof forever.
