every marks bounds &c as follows viz Beginning
on a Stake in center of R. & A. Air Line RR there
along the R. & A. Air Line RR to Spanish Oak 3x on
Chase's Branch Road thence up said Road to Black
Oak thence thence to Spanish Oak at the head of
the R. & A. Air Line RR thence N 87¹/₂ E 9.70 to Stone there
N 87¹/₂ W 18.40 to a Stone 3x3x m thence
N 87¹/₂ W 10.67 to a
Stone 3x3x m thence S 27¹/₂ E 4.03 to the beginning corner
and containing Fifteen Acres more or less
