The State of South Carolina 579

Known all men by these presents, that we James Nicoll and Mary Nicoll of Greenville County in the State aforesaid for and in consideration of the sum of fifty seven $\frac{1}{4}$ Dols to us in hand paid at and before the sealing of these presents, by Isaac Kelley of Greenville County in the State aforesaid, the receipt whereof is hereby acknowledged have granted bargained sold and released, and by these presents do grant bargain sell and release unto the said Isaac Kelley a tract piece or parcel of land lying and being situate in that County and State aforesaid on Panther Fork water of Marsh Creek of South Tyger River containing Seven and nine tenths (7 9/10) acres more or less being part of a tract of land conveyed to James Nicoll by Washington Nicoll the 13th day of March 1800 and runs as follows: Beginning on a Stake 3 $\frac{1}{2}$ on the Branch above where it runs into Panther Fork, thence S 39 E 1.75 chains crossing Panther Fork to a Stake 3 $\frac{1}{2}$ near a Sweet Gum tree S 15 1/4 E 3.44 chains to a small red oak 3 $\frac{1}{2}$ tree S 74 1/2 E 4.25 chains to a stone 3 $\frac{1}{2}$ D B Nicolls 3 $\frac{1}{2}$ then N 10 3/4 E 14.98 chains crossing Panther Fork to a Stone 3 $\frac{1}{2}$ tree 386 W 7.40 chains to Stake 3 $\frac{1}{2}$ in path or road thence S 43 1/2 W 4.03 chains to a Stake 3 $\frac{1}{2}$ in the Branch (stake down the meandering of said branch) to the beginning bounded by lands of Isaac Kelley and ourselves.

Together with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. To have and to hold all and singular the said premises before mentioned unto the said Isaac Kelley his heirs and assigns forever, and we do hereby bind our heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said Isaac Kelley his heirs and assigns, against us and our heirs and all other persons lawfully claiming, or to claim the same or any part thereof.

We have our hands and seals this day of in the year of our Lord one thousand eight hundred and seventy six and in the $\frac{1}{2}$ year of the Sovereignty of Independence of the United States of America.
