J. Cook Jr. in the State aforesaid. Manuscript whereof is herby acknowledged I have granted, bargained sold and released and by these presents do grant bargain sell and release unto the said H. J. Cook all that piece parcel and tract of land containing one hundred and sixty four and one fourth acres, situate lying and being in the County and State aforesaid, about four miles from the Village of Greenville on the Easty Bridge roads and Saluda river, the same being a part of the tracton which I now reside and conveyed to me by B. F. Perry and said to contain three hundred and forty three acres bounded by lands of the Estate of John Wilson deceased of D. C. Thornburg Dr. Rowleys and others beginning at a S. E. M. at N. 319 rods Rowleys corner and running thence N. 71° 11' 32" chs to a stone 3 rods from formerly at Brimble, B.C.M. out 36 4,112 rods. N. 67 W. 91,31 chs to a stone 3 rods from a sassafrass tree dead and down on road thence 837 ft N. 98 chs to a Maple st. up, to the head of a branch tree 359 ft. W. down said branch 6013 chs to a maple 3 rods from thence 628 ft. W. 56, on chs to the river wh. a large white oak 363 ft. 4 rods, thence down the meanderings of the river to a Willow 313 ft. 4 rods thence N. 28 1/2 E. 66, on chs to a stone 3 rods from in old field, thence 358 1/4 E. 29 1/2 chs to a stone 3 rods from road thence N. 15 1/2 E. 25 chs to the beginning black oak. Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. To have and to hold all and singular the said premises before mentioned unto the said H. J. Cook his heirs and assigns forever and to do hereby bind myself my heirs executors and administrators towards and forever defend all and singular the said premises unto the said H. J. Cook his heirs and assigns against myself and my heirs and all others whomsoever lawfully claiming on to claim the same or any part thereof.
